

<p style="text-align: center;"><b>VILLAGE OF ELAND CEMETERY</b> <b>Rules and Regulations</b></p>
--

1. The holder of burial rights is known as the lot holder. The lot holder has title only to the burial rights on a given lot, but not to the land itself. The title to all cemetery land remains with the Village of Eland.
2. Lot holders who wish to relinquish burial rights are to sell them back to the cemetery for the original price. The cemetery (Village of Eland) reserves the right to resell lots according to its own criteria.
3. All lots are sold with perpetual care included.
4. Burial lots must be paid for before a burial or placement of a monument or marker.
5. Restriction – Marker or monument must have name on it.
6. All burials, except cremains or infant burials must be in a steel or concrete vault. Cremains or infant burials must be placed in a non-biodegradable container.
7. One cemetery lot can receive one casket or two cremains, or one casket and one cremains.
8. Shepard hooks, candles, wreaths or flowers can only be placed on the tombstone or at the base extension. Artificial flower containers must be attached to the monument. Other containers will be removed. No glass or wire containers are allowed.
9. No feeders or functional bird houses, food or fencing are allowed.
10. Wreaths are permitted on graves for Christmas but must be removed by February 1 or the cemetery caretaker will remove and dispose of them. Any unsightly flowers, decorations, etc. will be removed.
11. Grass cutting will be done by the cemetery caretaker or Village-approved volunteer only. No weed or refuse should be left at the gravesite.
12. No shrubs or trees may be planted without Village approval.
13. No hunting, dogs, snowmobiles or ATVs are allowed in the cemetery.
14. It is the responsibility of the family to have headstones covered by their homeowner's insurance policy. The Village of Eland is not responsible for any repairs or replacement which might be required for damage by vandalism, vehicle, weather, etc.
15. Person responsible for snow plowing shall be responsible for opening gates on the first snowfall.
16. Spring clean-up is scheduled for April 1<sup>st</sup>, weather permitting. After October 15, the Village is not responsible for any disposed decorations.
17. Surcharge fees will apply for winter burials. Surcharge fee is due to the additional work necessary for winter season to prepare for burial. Fee of \$24.00 will be charged for reseeded (due to winter burn-off).
18. Burial permit only necessary if out-of-state body is brought back to our state.
